Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 1,583,694 shares or 10.89% of the common stock outstanding of Alaska Air Group Incorporated ("the Company") as a result of acting as investment adviser to several investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of common stock of Alaska Air Group Incorporated owned by the investment companies at June 30, 1995 included 646,586 shares of common stock resulting from the assumed conversion of \$13,900,000 principal amount of 6.5%Convertible Subordinated Debentures (46.517 shares of common stock for each \$1,000 principal amount of debenture) and 285,108 shares of common stock resulting from the assumed conversion of \$23,000,000 principal amount of the LYON (12.396 shares of common stock for each \$1,000 principal amount of the LYON).

Edward C. Johnson 3d, FMR Corp., through its control of Fidelity, and the Funds each has sole power to dispose of the 1,583,694 shares owned by the Funds.

Neither FMR Corp. nor Edward C. Johnson 3d, Chairman of FMR Corp., has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Fidelity Management Trust Company, 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 272,577 shares or 1.87% of the common stock outstanding of the Company as a result of its serving as investment manager of the institutional account(s). The number of shares of common stock of Alaska Air Group Incorporated owned by the institutional account(s) at June 30, 1995 included 97,686 shares of common stock resulting from the assumed conversion of \$2,100,000 principal amount of the 6.5% Convertible Subordinated Debentures described above, 24,792 shares of common stock resulting from the assumed conversion of \$2,000,000 principal amount of the LYON described above, and 87,199 shares of common stock resulting from the assumed conversion of \$2,000,000 principal amount of the Subordinated Debenture (29.76199 shares of common stock for each \$1,000 principal amount of the Convertible Subordinated Debenture).

Edward C. Johnson 3d and FMR Corp., through its control of Fidelity Management Trust Company, has sole voting and dispositive power over 272,577 shares of common stock owned by the institutional account(s) as reported above

Edward C. Johnson 3d and Abigail P. Johnson each own 24.9% of the outstanding voting common stock of FMR Corp. Mr. Johnson 3d is Chairman of FMR Corp. Various Johnson family members and trusts for the benefit of Johnson family members own FMR Corp. voting common stock. These Johnson family members, through their ownership of voting common stock and the

execution of a family shareholders' voting agreement, form a controlling group with respect to FMR Corp.
