The Company is amending an investor update furnished in an 8-K earlier this morning (March 13, 2020). The update should have stated our unrestricted cash and short-term investments balance as billions instead of millions. The updated wording is as follows:

As of March 13, 2020, including the borrowings from credit facilities, Air Group had unrestricted cash and short-term investments of approximately \$1.97 billion. Air Group also has 133 unencumbered aircraft that could be financed, if necessary, which could generate approximately \$2.5 billion.
